The source of information is SA 596-C whose identity is known to the Bureau and who advised that he believed that RUBY is possibly known to RALPH MITCHELL, BENNIE (LNU) who operates Bennie's U-Bar Guest Ranch, and PAT (LNU) who operates Pat's Dry Goods Store, all Bandera, Texas, and whom the informant believed engaged in gambling with RUBY.
