Enclosed are five copies for the Bureau of an LHM dated and captioned as above, setting forth information furnished by WF [6688-IA] to SA JAMES THOMAS FEILD on 9/13/76.

Asset advised the Soviet Embassy reception was scheduled for 6:30 p.m.-8:30 p.m., 9/9/76. He said he and his wife arrived at 7:30 p.m. and departed at 9:20 p.m. They were about the last to leave as most guests departed following the end of the two films about 8:30 p.m.

Concerning asset's and YERMISHKIN's reported comments concerning the assassination of President John Kennedy it is noted asset has been very active in assisting his Congressional employer in attempting to get legislation passed to reopen this investigation. As noted in LHM of 12/10/75 under subject's caption, when asset broached the assassination to YERMISHKIN, YERMISHKIN commented only to the effect that the Soviet Union could not have been involved. Asset stated on 9/13/76, that at the time of his discussion of the KENNEDY assassination he had had only one drink to his knowledge YERMISHKIN had had only one drink.
