CIVIL RIGHTS

The Bureau on 6/4/64, advised a number of offices that the President's Commission looking into the assassination of President JOHN F. KENNEDY was most interested in having EILEEN REDDON, aka., immediately located and interviewed regarding a statement she made to FBI agents in Los Angeles, California in 1956.

REDDON was a former subject of a closed WSTA case in which Cleveland was office of origin; however, she had not been seen in the Cleveland area for about four years.

CV-85-C on 6/5/64, telephonically contacted SA ARENDT, at which time she was asked if she knew the current location of REDDON. CI said she did not; however, REDDON's closest associate in Cleveland was a lesbian named NIKKI SHAW, 2549 Kenelworth Avenue, Cleveland Heights, Ohio, telephone YE 2-2614. CI said that SHAW formerly worked as a bartender at Joãñ's Bar, 1600 Payne Avenue, Cleveland, which is a homo-sexual hangout.

CI said that SHAW was the manager of the homosexual hangout called the "Down Beat Club" when REDDON operated this place in Cleveland several years ago. She likewise said that SHAW was going to testify as a state witness for the Cleveland Heights Ohio Police Department concerning a burglar by the name of PETER TITUS.

CI suggested that SHAW be contacted as she felt certain she would know the current location of REDDON.
