On December 10, 1963, PCI advised as follows:

About 1948-1949, BOB MULLENIX, a private investigator, conducted an investigation concerning PAUL DORFMAN's entrance into the Waste Paper Handlers Union, Chicago. It is possible information developed in this investigation would concern JACK RUBY and his association with DORFMAN.

Subsequently, MULLENIX was working for AL JOHNSON at Investigators, Incorporated.

About November, 1962, MULLENIX was killed in an automobile accident in Chicago. After MULLENIX's death, his investigative files were sent to a brother, JOHN C. MULLENIX, at 1232 West Maypole South, Springfield, Illinois. It is possible these files may contain information regarding RUBY.

PCI will not testify to the above.
