Noted serial 57 is a teletype from Dallas instructing certain offices to contact Security Informants, Racial Informants, PSIs and any other appropriate sources in connection with possible demonstrations to be held at the time that RUBY appears in court in Dallas on 12/23/63. The teletype instructed, "Sutel Bureau and Dallas any pertinent developments."
