CIVIL RIGHTS

Noted Butel to all offices dated 11/25/63 instructed "all offices contact gambling informants as possible source of information regarding RUBY".

All Agents were immediately contacted and it was determined that only SAs HAROLD H. BOYCE and ROY C. DAHL had any gambling informants. They made the following contacts on 11/25/63 and were able to develop no pertinent information regarding RUBY, except for the information furnished by PCI JOSEPH LEWIS PRENSKY, contacted by SA BOYCE. PRENSKY's information was furnished to the Bureau and Dallas in El Paso teletype dated 11/25/63, 3:35 pm (See serial 3):
