Informant advised that no information regarding Lee Harvey Oswald or his activities have come to informant's attention. Informant has never met anyone who has claimed to know Oswald or have any knowledge of his activities.

Informant stated there has been no effort at SUI to form a new youth group, and informant has had no indication that students are being asked to attend a convention at Chicago, Ill.

Informant stated that Kenneth F. Rosen is known slightly by informant. Informant has never heard Rosen make statements to indicate membership in the ~~KKK~~ CP, nor has informant ever heard Rosen deny he is member of CP.
