Enclosed for the Bureau are the original and four copies of an LHM; two copies each of the LHM are being furnished to Dallas and Newark. The LHM reflects information furnished by LV 1350-PC. Source does not wish to be identified outside the Bureau and will not talk to anyone outside of the Bureau.

The information given by the source is of unknown value and is being furnished to the above offices in the chance that it may have some bearing on captioned case. If information is of value, receiving offices requested to notify Las Vegas. Source is now furnishing this information inasmuch as there has been a renewed interest in the JOHN FITZGERALD KENNEDY assassination. No leads are being set out by Las Vegas. Leads are being left to the discretion of the Bureau.
