Informant said that MEYERS' comments arose during a discussion at the club meeting concerning a former club member who had been suspected of being an FBI informant. MEYERS told the club members not to feel too badly; that he had paid CP dues for a number of years to one man, only to learn that this man was in the employ of the FBI. It was during these comments that MEYERS made his statement relative to OSWALD. PD 506-S said that he did not elaborate or provide additional comment of any kind, and that this was all the information available concerning the matter.
