regard to Cuba. This report further reflected that BUCHANAN, in addition to being a newspaper writer, was getting involved personally in revolutionary activities pertaining to Haiti and Cuba.

Miami file 47-4019, Bufile 47-48702, pertains to a fugitive investigation on JERRY BUCHANAN, FBI #148937D, the brother of JAMES BUCHANAN. That case involved the use of U.S. Army identification in the name JESSE L. MURPHY by JERRY BUCHANAN in cashing three stolen checks at Mlami. That file reflects the brother of JERRY BUCHANAN as JAMES CHARLES BURHANAN, and the parents as JAMES and WARY BUCHANAN, 3543 Northwest 33rd Street, Miami.

Miami file 2-317, Bufile 2-1712, also pertains to JERRY BUCHAMAN, FBI #148937D, and this case was based on recruiting activities by JERRY BUCHANAN for the Anti-Communist International Brigade of FRANK FIORINI. same file reflects JERRY BUCHAMAN was sent to the Florida State Penitentiary as of 7/28/61 for three years as a Parole Violator from a forgery conviction.
