Dear Mr. Hoover:

Thank you for your letter of February 21, 1964, in which you advise that your Bureau is determining whether Salvador Diaz Verson will undergo a polygraph examination.

- In connection with this matter, I have recently been wondering whether there is any identity or relationship between Dr. Borrell Navarro, named by Verson as his source, and Horacio Duran Navarro, the husband of Silvia, who had contact with Oswald when he visited the Cuban Embassy in Mexico City. We note that sometimes your reports refer to Verson's alleged source as Navarro and at other times as Navarros.

- The Commission has requested me to ask that your Bureau and any cooperating agency consider this possibility and appropriately investigate it. I am assuming that you are in possession of translations of the interrogation reports prepared by the Mexican police based upon their interviews of Silvia Duran, her husband, and others detained at the home of Silvia's brother-in-law.

Thank you for your continuing cooperation in the work of this Commission.
