DETAILS:

The Informant submitted a written report in which he advised that so far things are just about the same around the CP Club in Muskegon. He stated that there is nobody who would start to revive the CP movement, or start a meeting for the CP. He advised that in Muskegon they are still some of the old IWO members, and a few of them are against KHRUSHCHEV and are still praising STALIN, but not in the open. It was the Informant's opinion that none of these people would come to a CP open meeting if someone had come to Muskegon to speak.
