On July 2, 1964, [SA 648-S] furnished the writer an oral report which was subsequently transcribed and thereafter authenticated by Informant on July 2, 1964. This report is located in [134-363A-334] and contains the following information: (u)

At about 6:30 p.m. on July 1, 1964, RENE SANDOVAL was observed driving to the north side of the Office Bar on San Pedro Avenue, San Antonio, Texas. SANDOVAL was observed talking to JOHN STANFORD who was sitting in STANFORD's car. (u)

Thereafter STANFORD got into SANDOVAL's car and the two drove to the Paul Marie Drive-In on Zarzamora Street, San Antonio, Texas. SANDOVAL was heard to tell
