On 12/9/63, SF 2287-S, who has furnished reliable information in the past, furnished SA SAMPLE with a handwritten report concerning a CP Club Meeting held 11/27/63, at the residence of SAUL WACHTA, San Jose.

Informant report is set out verbatim below:

"11/29/63

"On November 27th, I attended a meeting at the home of Mr. & Mrs. Watha. This was our regular club meeting. Members present were Barbra Lindsay, Ray & Betty Anderson, Frances and Vivian Fink, Saul & Billy Watha, Emma Sterne and Willie Norman.

"We had a one point agenda, the death of the President, and who was the blame and what could the Communist Party do about. Barbra Lindsay said she thinks the party should prove the public that we did not have anything to do with it, because we are being blamed for all kind violence and this is what H.U.A.C. would like to hang the party with.
