INFORMANTS

On 1/27/67, HO 1934-G, Aransas Pass, Texas, advised CLIFTON JOHNSON, JR., was known to her, but she did not know his present whereabouts or how to reach him.

On 1/23/67, HO 1150-C, Aransas Pass, informed he is well acquainted with CLIFTON JOHNSON, JR., who was at that time on a fishing trip in the Gulf of Mexico, and who would no doubt return to Aransas Pass shortly.

On 1/27/67, HO 1150-C furnished information that CLIFTON JOHNSON, JR., was at that time at the Beach Grill at Camp Brown Harbor. JOHNSON was thereafter located at that place, which is owned and operated by HO 1150-C.
