HOUSE SELECT COMMITTEE ON ASSASSINATION (HSCA), BUFILE 62-117190.

CO 80-C (FORMERLY CO 80-S) WAS CONTACTED THIS DATE BY MARK A. STEISER AND ROBERT A. WALKER, STAFF INVESTIGATORS FOR CAPTIONED COMMITTEE. THEY VISITED WITH CO 80 AT HIS RESIDENCE AND INTERVIEWED HIM IN DETAIL CONCERNING ANY KNOWLEDGE HE MIGHT HAVE OF THE REV. MARTIN LUTHER KING ASSASSINATION AS WELL AS KENNEDY ASSASSINATIONS. HE HAS BEEN SUBPOENAED FOR CLOSED HEARING JUNE 6, 1978, AT WASHINGTON D.C. AND WAS TOLD BY

ABOVE INDIVIDUALS THAT HE WOULD BE ASKED ADDITIONAL QUESTIONS NOT PRESENTED TO HIM AT MEETING THIS DATE. CO 80 REQUESTED GUIDANCE FROM THE BUREAU AS TO WHETHER OR NOT HE SHOULD REVEAL TO COMMITTEE HIS CONFIDENTIAL RELATIONSHIP WITH THE BUREAU. THE BUREAU IS REQUESTED TO ADVISE IF CO 80 SHOULD MAKE AVAILABLE TO COMMITTEE HIS INFORMANT RELATIONSHIP.
