MARIE DRITSAS, BORN TEN TWENTY TWO THIRTY SIX, NEW YORK,  
BUFILE ONE HUNDRED DASH FOUR THREE ONE THREE ZERO FIVE,  
NYFILE ONE HUNDRED DASH ONE THREE SEVEN SEVEN ONE SEVEN, BE-  
LIEVED IN HAVANA, CUBA. NO ACTIVE INVESTIGATION CONDUCTED  
AT SEVILLE AND CRYSTAL BARS, NYC, INASMUCH AS THERE APPEARS  
TO BE NO NEED TO DETERMINE WHEREABOUTS OF ALL FPCC SPEAKERS  
AT THIS TIME.
