SYNOPSIS:

Basis: Report in 1952 that Mrs. WILLIAM A. HYDE, employee's mother, had admitted to neighbors that she was a Communist. Original source of this report contacted and advised this was rumor and she was unable to furnish basis for rumor. Brother of this source advised she is in poor health, forgetful, and suffering from mental disorder. Employee's education, Antioch College, verified. Short term employments, 1945, 1946, 1947, and 1948 not verified, there being no available records. Professors and neighbors acquainted with employee consider her of good character, reputation, associates and loyalty. Several neighbors of employee's parents advised of rumor that Mrs. HYDE, employee's mother, was a Communist but none knew basis for rumor and knew of no information other than this rumor reflecting on character, reputation, associates or loyalty of employee's parents. Several neighbors volunteered employee's parents entertained persons of different races in their home. No credit
