He is also listed as a property owner the Third District. Nothing Derogatory; Inquiry made 9/22/61.

Hugh, W. Mc Millan, Building Manager, Masonic Temple Bldg. New Orleans advised that GEORGE LONGE has in the past been the Commander, of the Supreme Council of Louisiana, Scottish Rite Free Masonry. While Mc Millan does not know of him personally he ~~did~~ did state that most of the negroes who have been officers of that group have been persons of good character and morals and persons about whom he had not heard anything derogatory.
