SUBJECT: ASSASSINATION OF PRESIDENT OF THE UNITED STATES, 11/22/63 - INFORMATION CONCERNING

MRS. GUSSICKS, 1701 Courtland, TA-3-9480, telephonically contacted this office this date and stated that she is a student at the NORTH WEST SCHOOL OF BEAUTY CULTURE, Des Plaines, Illinois.

MRS. GUSSICKS advised that one GERALD SHORTALL, 738 S. Home, Park Ridge, Illinois, is also a student at the above school and in the past has distributed "communistic literature" to the students.

Upon hearing the news of the ASSASSINATION of The President, SHORTALL stated "OH! That's wonderful, he was a criminal."

The caller stated that due to SHORTALL'S emotional outbursts against the President, he was told to leave the school. MRS. GUSSICKS stated that she could not furnish any information regarding SHORTALL'S background other than the above. She was polite and coherent and sounded sincerely concerned regarding this matter.
