On 12/9/63, the writer received a written report from SA 648-S which report is located in 134-363A-171, and which contains the following information:

On Wednesday, December 4, 1963, at about 9:30 p.m. TED CASTILLO & JOHN STANFORD were seen at the S-N-S Ice House Driveway.

SANDOVAL, CASTILLO and STANFORD then decided to hold the CP meeting at the S-N-S Ice House Driveway.

TED CASTILLO led the discussion on Chapter 10, "Present Day Imperialism," of the book, Fundamentals of Marxism-Leninism.

CASTILLO stated that present-day imperialism is on its last stage and that socialism is within our reach. STANFORD agreed and therefore made the statement why capitalism will not continue to grow in America. STANFORD claimed that the capitalists will not be able to continue to exploit the people too much longer.

In dues, RENE SANDOVAL paid \$1.00 for the month of December. STANFORD stated that the CP of Texas must raise more money to continue its functions.

JOHN STANFORD stated that the death of President KENNEDY had been a terrible thing. STANFORD blames the right-wing element for the killing of the President.

STANFORD stated that the Communist Party would not tolerate such a killing as that of the President.

It was decided to hold the next CP meeting December 18, 1963, at the Hacalla Cafe on Market Street, San Antonio, Texas, at 9:30 p.m.
