DN 215-S, who has furnished reliable information in the past and is cognizant of Communist Party activities in Denver, Colorado, furnished the following information to SA JOSEPH C. LEARNED on 1/31/68:

A meeting was held on January 28, 1968, at the home of BOB LYONS, 2861 South Forest Street, Denver. The purpose of the meeting was to attempt to form some sort of ad hoc committee to support GARRISON in his investigation of President KENNEDY's assassination. It was planned that the committee would be a loosely formed committee and would only function to send out press releases supporting GARRISON's actions and protest what is believed to be an attempt by the United States Government to "put him away" by saying that he is psychotic. What the committee does will be determined by how GARRISON's case is receiving publicity.

The press release will be sent out soon reporting that this group believes that GARRISON should be left alone to carry on his investigation of the KENNEDY assassination.

DN 215-S reported that <u>ROBERT TRUJILLO</u> and <u>NELLE</u> <u>GARCIA</u>, members of the CP, were present at this meeting. DN 215-S reported that approximately 13 individuals attended this meeting and that the majority of these individuals have been active in the activities of the Denver Stop the War Committee.

As of August, 1966, the Denver "Stop the War Committee" had been holding meetings and sponsoring demonstrations in Denver, Colorado, protesting United States policy in Vietnam. This committee is an ad hoc type committee utilized to lend a sponsor name to demonstrations. MARY WALTER is chairman of the committee and various members of the Denver Branch, Socialist Workers Party (SWP), are generally the guiding figures in all Vietnam demonstrations.

MARY WALTER was secretary of the Denver Chapter, Fair Play for Cuba Committee (FPCC).
