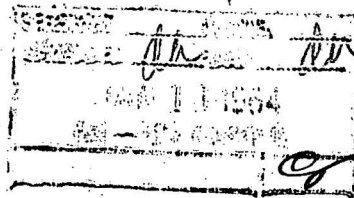

"Jan. 6 1964

"On Dec. 7, 1963 NOEL TOTTON visited the home of CLUDE MC DONALD at 1621 5th St. North Minneapolis, Minnesota. NOEL arrived about 11:00 A.M. and left his house about 12:30 P.M. They discuss the assassination of President KENNEY and some of the questions on peace.

"MC DONALD said that the reason the President was killed was because of the hate campaign which has been build up in this country over the past years. MC DONALD did not think that there would be any change in the relation between the United States and the U.S.S.R. as the present state of affairs was not only President KENNEY's feelings, but also other officers of the Government as well.

"MC DONALD ask NOEL TOTTON if he would take the "Worker" and NOEL said that he would and would come back around the first of the year and give him money for a Worker subscription.

"MC DONALD talked about the indictment of RALPH TAYLOR and BETTY SMITH, saying that the judge decided to wait until the HALL & DAVES case was settled before they would have a trial, if any.

"This is all I have to report."
