CIA apparently made contact with him in Kurope thru Cuban exile in New York who is long-time friend of a distribution of the Cuban exile Tho confided that he had been acting as contact man between CIA and subject. According to Cuban exile, subject complained to him that CIA refuses to furnish him with certain equipment with which he could take some effective action in Cuba and that CIA furnishes him with bulky unservicable equipment rather than compact equipment with which he could possibly eliminate Castro. to kill Castro

According to Cuban exile there is some plan funder discussion, details of which he did not know, in which subject would figure. CIA allegedly was in favor of plan, however, Attorney General would have no part of read to was shelved.
