2. Will interview RAMON QUESADA to determine whether he will furnish any information regarding raid against Tarara, Cuba, 5/19/63.

- ADMINISTRATIVE -

Regarding Bureau teletype 6/14/63 setting out information from CIA alleging raid on Cojimar, Havana, it is noted that no data which would tend to substantiate this information has been developed and it was, therefore, not included in this report.

This report has been classified "Secret" because it contains information from CIA memoranda so classified.

Regarding Lead #3 in referenced report, investigation has determined that RENE CRUZ PEREZ is presently residing Room 214, Barlington Hotel, 1350 N.W. 2nd Street, Miami, but to date efforts to contact him there have been negative.

Referenced report lead #2 to interview ERNESTO DIAZ, 552 N.W. 31st Street, is outstanding. As two SNFE

boats are maintained to the rear of the DIAZ residence and are presently being spot checked on a daily basis, further efforts to interview DIAZ at this time would interfere with this coverage.

Regarding Lead #4, inquiry in the vicinity of the Standard Oil Station at 4420 N.W. 7th Avenue reflects this station is operated by Cubans and that almost all business is with Cuban exiles. In an effort to obtain some coverage on this station on the possibility that the SNFE is obtaining gasoline there, [REDACTED]

[REDACTED] has been contacted as a source in the regard. [REDACTED] is most cooperative, anti-Cuban, and stated he will immediately contact the office when he observes large amounts of gasoline being purchased from this station.

Source

[REDACTED] said that on several occasions in the past he had observed as many as six 55-gallon drums being loaded and transported from the station during the course of one day by individuals whom he considered to be Cubans. No direct contact will be made with the proprietor of the Standard Station at this time.

Regarding the information furnished by CIA concerning alleged surveillance by FBI, it is to be noted that the only surveillance conducted by Miami has been the spot check of SNFE boats. Mention by RAMON QUESADA of the bank account of SNFE indicates that [REDACTED] at the Boulevard Bank, advised SNFE of our inquiry. It is noted [REDACTED] is a Cuban friend of VECIANA.
