1. HAVE FURNISHED LEGAL ATTACHE ALL PERTINENT INFORMATION FROM ~~EMBASSY~~ ON OSWALD CASE, INCLUDING BRIEF MEMORANDUM DATED 16 OCTOBER 1963 ON OSWALD'S CONTACTS WITH THE SOVIET EMBASSY.

2. IN ALL REPEAT ALL CASES HAVE PUT STATEMENT "THIS INFORMATION IS FROM A CONFIDENTIAL SOURCE. IT MUST NOT BE DISSEMINATED IN WHOLE OR IN PART OUTSIDE YOUR OFFICE WITHOUT PRIOR APPROVAL OF THE ORIGINATING OFFICE IN MEXICO CITY."

3. ON 27 NOVEMBER COS TALKED WITH LEGAL ATTACHE AND MADE ~~TWO~~ FOLLOWING POINTS:

A. WE WISHED HIM CITE KUBARK AS THE SOURCE OF ALL REPEAT ALL INFORMATION HE RECEIVED FROM THIS STATION AND SENDS TO HIS HEADQUARTERS.

B. WE REQUIRE THAT NO REPEAT NO DISTRIBUTION OF KUBARK INFORMATION BE MADE OUTSIDE THE LEGAL ATTACHE'S
