SINCE U.S. IMMIGRATION RECORDS SHOW NEXT TO NOTHING ON THE TRAVEL OF U.S. CITIZENS, PLEASE ASK MEXICAN IMMIGRATION TO CHECK ALL THEIR RECORDS SINCE JUNE 1962, WHEN OSWALD RETURNED FROM THE SOVIET UNION, TO SEE IF HE ENTERED OR LEFT MEXICO AT ANY OTHER TIME THAN THE 26 SEPTEMBER TO 3 OCTOBER 1963 PERIOD. WE STILL DO NOT KNOW WHAT IF ANYTHING OSWALD TOLD HIS DALLAS INTERROGATORS ABOUT TRAVEL TO MEXICO.
2. WE ALSO NEED INFORMATION ON WHO TRAVELED WITH HIM AND WHAT VEHICLE HE USED ON HIS SEPT-OCT 63 TRIP AND ON ANY OTHER TRIPS.
3. DOES MEXICAN GOVERNMENT HAVE ANY WAY OF TELLING WHAT OTHER TOURIST CARDS HE MIGHT HAVE HAD? IF SO, PLEASE ASK THEM.
