HITHERTO UNIDENTIFIED AMERICAN PHONED CUBEMB 19 JULY TRYING FOR SECOND TIME IN WEEK TO ESTABLISH CONTACT, SPOKE IN ENGLISH WITH MARIA LUISA CALDERON, SAID LEAVING FOR DALLAS ON AMERICAN AIRLINES MORNING 20 JULY, STAYING AT ROOM 1402 ALAMEDA HOTEL, REFUSED GO CUBEMB BECAUSE POSSIBILITY AMERICAN SPY MIGHT SEE HIM.
2. AT STATION REQUEST ~~AMSA IL-1~~ POSING AS CUBEMB OFFICER MADE CONTACT ON HOUSE PHONE AFTERNOON 19 JULY, ALLUDED TO CALL TO EMBASSY, LURED SUBJ TO HOTEL RESTAURANT. SUBJ IDENTIFIED SELF AS ELDON HENSEN, CATTLEMAN, ATHENS, TEXAS, PHONE OR-54787. SAID WILLIN HELP CASTRO GOVERNMENT IN US, WILLING TRAVEL, HAS MANY GOOD CONTACTS IN STATES, CAN "MOVE THINGS FROM ONE PLACE TO ANOTHER". ~~A-1~~ SAID WOULD HAVE TO CHECK OUT SUBJ FIRST, SOME DELAY INEVITABLE. WARNED SUBJ NEVER AGAIN PHONE CUBEMB, TOO DANGEROUS. SUBJ SAID WANTS MONEY FOR COOPERATION, IS NOW UNDER FINANCIAL PRESSURE. SUGGESTED ~~A-1~~ OR REPRESENTATIVE CONTACT HIM IN STATES BY PHONE, NOT VISIT. SUBJ FAMILY NOT AWARE HIS TRIP TO MEXI. ^{SAID THIS} ~~25 543~~ HIS SECOND TRIP MEXI SPECIFICALLY TO ESTABLISH CONTACT WITH CUBEMB.
