Re: Edward Scannell Butler.

On 26 Oct. 1966, Butler was in New York City re: a documentary film that he has produced about Castro (comparing him to Hitler). It was shown on a local TV station.

Butler claims that the film is based on inside material and includes Cuban newsreel film that he was able to obtain through devious means. The production was financed by Patrick J. Frawley, through Technicolor (?). Butler is working as a consultant for Frawley and has an office (at Schick Co.?) in Los Angeles - 567 Comstock Ave. Phone: 271-1295.

Butler said that he's trying to get Frawley to consolidate his anti-communist activities. There was the strong implication that this might cut into Frawley's support of the American Security Council. Butler claims to be very close to Frawley.

In New York, Butler was with Lee Edwards, a public relations man for Young Americans for Freedom and other conservative causes, talking over possible joint projects in the future.

Butler is the head of the Information Council of the Americas (Inca), 4719 Dryades St., New Orleans, La. Phone: TW-5 9086.

In 1963, just a few weeks before President Kennedy's assassination, Butler had a radio debate against Lee Harvey Oswald. It was taped, and Butler has made a record of it.
