In connection with its investigation into the circumstances surrounding the death of President Kennedy, the Select Committee on Assassinations requests access to all files and index references pertaining to the following individuals:

- *1) Barney Baker - Address in 1963: 5900 Sheridan Road, Apartment 5-E, Chicago, Illinois. Telephone: RA8-4031. Former organizer for the Central State Conference of the International Brotherhood of Teamsters Union. Former employee of Teamster's President, James Riddle Hoffa. Released from Sandstone Penitentiary on 7 June 1963. Employed as a field representative for Chicago Loop Auto Refinishing Company, Inc., in January, 1964.
- 2) Bunny Breen aka Eileen Curry aka Carol O'Connor - Date of birth: 3/27/24. FBI interview with Breen dated 6/11/64 is located in Jack Ruby file, Serial 1644, pp. 10-20.
- 3) James Eckford Breen - Date of birth: 1/4/28. U.S. Coast Guard Z No. 455024; FBI report from San Fran office dated 6/19/64 in Jack Ruby file, Serial 1841, pp. 1-4.
- 4) Thomas E. Davis, III - Deceased. Prior conviction in bank robbery in approximately 1959. Formerly of Beaumont, Texas.

- *5) Dewey F. Groom - Address in 1963: 2631 Fonville, Dallas, Texas. In 1963 occupation was manager of the Longhorn Ranch Club, Dallas. FBI interview dated 12/15/63, file #DL 44-1639.
- *6) Peter Guarisco - In 1963, manager of the Newport Hotel, Morgan City, Louisiana. Alleged associate of Carlos Marcello. FBI memo from New Orleans to Director dated 12/20/67 from Ruby file, Serial 2145, Section 89.
- 7) Milton Jaffe - Jaffe was the subject of an anti-racketeering case in Las Vegas in 1963. On 12/18/63 the FBI's Las Vegas Field Office contacted Jaffe. Address at that time: Stardust Hotel and Casino, Las Vegas. The report of this contact is contained in the Jack Ruby file, Section 36, Serial 921, p. 257.
- 8) James Herbert Martin - Address in 1964: Farrar Street, Dallas, Texas. Employed 1962-64 as hotel executive for Six Flags Motel in Dallas. Testimony before the Warren Commission: 1 H 469-502 and 2 H 1-32.
- 9) Mrs. James Herbert Martin - Wife of James Herbert Martin.
- *10) Nofio Pecora - Brother-in-law: D'Alton Smith. Congressional Record 1970, page 27751 indicates that a "Nofie" Peeoraro was arrested in a guns-for-arms smuggling case in Honduras.
- *11) Helen Afance Roan aka Helen Afance Cooley, Mrs. Ray E. Cooley, Mrs. Al Hipper, Mrs. Billy Murl Roan, Helen Woods, Helen Holliday, Helen Holly. Maiden name: Krainova.
- 12) Joseph E. Slatin - Date of birth: 1915. Address in 1963: Dorchester Hotel, Apartment 801, 911 St. Joseph Street, Dallas, Texas.
- 13) Irwin S. Weiner - Address in 1963: 7345 North Damen, Chicago, Illinois.
- 14) Edward P. Morgan - Date of birth: 5/28/19. Currently a Washington, D.C. attorney.
