The following information was furnished on November 19 and 24, 1964, by Dallas T-1:

Dallas T-1 advised that he is presently a member of a group referred to as the "Minutemen" and "American Underground" and has been so since approximately 1962. Dallas T-1 advised that the organization is nationwide with approximately fifteen to thirty members in Tarrant County. Dallas T-1 stated that the name of the organization as such has only been used twice in two years and that proper names are seldom, if ever, used and that this makes it very difficult to determine identities of members. Dallas T-1 advised that the following are currently members of the organization:

Arthury Pollard, 2707 Berryhill Drive, Fort Worth, Texas

Otto (Duke) Koling and Shirley Bob Renshaw, 2341 Harris Lane, Haltom City, Texas, who lives with Koling.

Bill Seals, employed at Montgomery Ward's and recently transferred to Montgomery Ward's, Houston, Texas

Van Pollard, 3421 Hanger, Fort Worth, Texas

Closely associated with the organization and perhaps a member is Richard W. YDawson, who lives on Highway 121 on the outskirts of Fort Worth and who has formerly lived in the neighborhood of 2820 Kerthwest 29th in the early 1950's. Dallás T-1 advised that an attorney whom members of the group have been advised to contact if "they get into trouble", is W. Alfred Windor with offices in the Ellis Building in Fort Worth.

Dallas T-1 advised he does not know whether or not Windor The I have is a member of the organization.

Dallas T-1 advised the primary purpose of the organization is to fight against the present Federal control of national and local Governments and to fight for "States' rights". The group is supposedly national in origin and believes that the Federal Government is in the process of selling out to the communists and that the group is the last line of defense against this sellout. The group secondarily is racial in that it believes in white supremacy. Dallas T-1 advised that the organization suffered a severe setback because of the assassination of President Kennedy but now is. attempting a full-scale reorganization. The group recruits basically from those who do not have criminal records and is organized in such a manner that no one is supposed to know the names of other members in the organization. This is to prevent effective infiltration by the Government. Ballas T-1 advised that the group has no immediate plans for action, but that several times locally this group has determined to act on their own and this action; has been curtailed because of orders relayed from higher authority in the organization. These higher authorities are unknown to Dallas T-1, except that a person by the name of Ray (last name unknown) at the ranch in the vicinity of Venus, Texas, appears to be in contact with the group's organizational leaders. Ray is described as a personal and close friend of retired General Edwin Walker and about one and one-half to two years ago was apparently implicated in some manner in the burning of a newspaper in the area of Midlothian. Texas. Ray is also apparently a warehouse supervisor in Dallas.

Dallas T-1 also advised he has been recently contacted by a man whom he does not know but who apparently lives in the Fort Worth area, and this unknown male advised Dallas T-1 to disassociate himself from the small group he is now

attached to for the apparent purpose of moving into a position of more prominence in the organization. Dallas T-1 advised that the small group with which he has been associated is the lowest level in the organization and that their primary purpose is to do the "dirty work".

Dallas T-1 stated that the group is also prepared. in the event of a Kegro uprising in the Fort Worth area, to take action against various Negro leaders including Dr. Flint, Dr. Fleming and Dr. Ransom, and a Fort Worth hoodlum named Madison Hogan, who is apparently a Nation of Islam leader. in the Fort Worth area.

Dallas T-l advised that the only overt action tentatively planned for the winter months is that the effect of a .30 caliber rifle on power transformers in the area may be tested. Dallas T-1 further stated that the group apparently has a contact with an individual in northeast Texas who goes by the name of "South" and that this contact may be utilized in the raiding of a northeast Texas armory during the winter The primary interest is obtaining mortars and mortar ammunition and automatic weapons; therefore, Dallas T-1 believes that the armory would probably be of a tank or infantry group.

Dallas T-1 advised that the group locally is attempting to gain control of the Panther City Motorcycle Club for the purpose of gaining land apparently owned by this club, in the area of Lake Arlington, Texas, and thereafter selling this land and using the monies therefrom for purchases. of the group.

Dallas T-1 advised that it has been learned the group has organizations in Stephenville, San Angelo, Italy and Brownwood, Texus. Dallas T-1 further advised that Arthur, Pollard has in the past made trips to Alabama, Wyoming, Montana, California, and that the group has a contact with an individual by the name of Jim Scott in Kansas City. Dallas D. Andrew T-1 advised that he has seen pamphlets from national Minutemen headquarters, but that these dealt primarily with the fighting of any Kational Firearms Act which would involve licensing of private weapons.

Dallas T-1 advised that several members of the group are personally acquainted with General Edwin Walker and he apparently has a capacity of being an advisor. The group does not apparently have any connection with the American Fazi party or with the Ku Klux Klan. The group is organized into small cell-like bodies and the meetings of these are never held on a regular basis and are generally held in public places at night with from five to fifteen people in attendance. Benbrook Lake Park and Eagle Mountain Lake area have been two places where the group has met in the past, although often the meeting will be a "moving one" in someone's automobile. The group's meetings are never planned in advance as far as Dallas T-1 knows, inasmuch as Dallas T-1 is always notified personally by someone in the group generally within an hour to thirty minutes ahead of a meeting time, and is then picked up and taken to the meeting place. Many of the members of the group have walkie-talkies although some members do not.

Dallas T-1 advised that it is suspected that a Dallas gunsmith by the name of John Thomas Kasen is at least sympathetic to the purposes of this group, although he is not known by Dallas T-1 to be a member of the organization. This belief is based on the fact that Dallas T-1 has in the past seen Masen in the company of Bill Seals.

On Movember 19, 1964, Dallas T-2 and Dallas T-3, sources which have knowledge of Nation of Islam activities in Fort Worth and Dallas areas, individually advised that they bad no information concerning the connection of a Madison Hogan with Mation of Islam activities in the Fort Worth-Dallas area.

On November 19, 1964, Lieutenant E. F. Eopkins and V. T. Summers, Intelligence Unit, Fort Worth Police Department, advised they had no information concerning activities of a Minutemen group or of a group similarly inclined in the Fort Worth area.

On November 6, 1964, a check of current Fort Worth directories reflected no information concerning a Otto Koling or Bill Seals.

On November 6, 1964, Operator 98, Fort Worth Retail Merchants Credit Association, 508 Commerce, advised that agency had no record re Otto Koling. Operator 98, advised, however, that the following information pertained to an Arthur Austin Pollard, married to Betty Jane Noles, previously married to Lillie. His nearest relative is Mamie Gaines, 3432 Hanger Street. Arthur Pollard was born September 15, 1934, and served in the United States Marine Corps from July 25, 1952, until July 24, 1956, during which time he lived at 41F WAYAR Housing, El Toro, Santa Ana, California, USYC, and was last employed by Exchange Parts, Fort Worth, in the assembly section.

On November 6, 1964, Operator 98 furnished the following re Shirley Bob Renshaw. Wife Marion Helen, previously married to a Helen Sullivan. In September, 1963, Benshaw was the assistant manager of Sky Hobby Shop and apparently is now employed with "Abe Terrell". In March, 1964, he lived at 2341 Harris Lane, having moved there from 2603 Gorman in Waco, Texas. Renshaw apparently moved to Waco, Texas in September, 1963, returning March, 1964 to Harris Lane address. Renshaw formerly was employed with Cromer

On Kovenber 6, 1964, F. M. Alexander, Identification Division, Fort Worth Police Department, advised he had no record identifiable with Bill Seals or Otto Koling.

The manager of Palm Center store is A. L. James. Seal's personnel record was sent to Houston on his transfer. George was not personally acquainted with Seal.

On November 10, 1964, Operator 54, Fort Worth Retail Merchants Credit Association, 508 Commerce, advised that agency had no information regarding Bill Seals, Seal or Seale. It is noted that the current Fort Worth City Directory reflects William H. Seale, 2185 Weatherbee, as working for Auto Service - Ward's.



On November 11, 1964, a telephone call to the Maremont Corporation, Fort Worth, Texas, verified Van Pollard's employment at that agency.

On November 19, 1964, W. M. Young, Tarrant County Sheriff's Office, Identification Division, advised he had no record identifiable with William H. Seale. In reference to Richard W. Dawson, a Richard Never Walter Dawson was received in 1941 on a burglary charge and thereafter received a two year suspended sentence. Dawson's address at that time was 2912 West Lancaster. Notations in the file indicated Dawson had been handled several times as a juvenile, Tarrant County Sheriff's Office #10705, Fort Worth Police Department #13945, FBI No. 3950242.

On November 19, 1964, Operator 4, Fort Worth Retail Merchants Credit Bureau, 508 Commerce, advised they had no record regarding Richard W. Dawson.

On November 19, 1964, F. M. Alexander, Identification Division, Fort Worth Police Department, advised he had no record re William H. Seale and made available the following information concerning Richard W. Dawson: White male American, born July 14, 1926, Leavenworth, Kansas, handled as a juvenile for burglary on November 14, 1941, at which time he received a two year suspended sentence. It is noted Dawson was 15 at the time. Dawson picked up as subject of several investigations between 1941 and 1946, but no charges filed. Last notation in record was 1951, chauffeur's application. Address listed at that time as 2820 Northwest 29th, Fort Worth.



On December 3, 1964, Dallas T-1 advised that Arthur Polland and Otto (Duke) Koling have recently decided that the local Minuteness organization may be moving too slowly and they are going to attempt contact with the leader of the American Eszi Farty, Lincoln Bookwell, in an effort to evaluate his policies.

Dallas T-1 advised "South", referred to previously, as this group's contact in a possible raid on an armory in Northeast Texas, is a caretaker at an Armory, he now believes is located mear Cooper or Paris, Texas. Dallas 7-1 advised in the organization now is to get more members. the stress

Detective Loyd Mathers, Paris, Texas Police Department, advised on December 11, 1964, that a Luther South, commonly referred to as "Pop", had been employed by the Mational Guard Armory, Greenville, Texas, until about March, 1964. Due to the re-organization in the Guard by the State of Texas, South had been transferred to North Port Hood, Texas, and equid be located at the first building on the left after you enter the Forth Fort Hood entrance on the highway coming from Gatesville, Texas, to North Fert Ecod. Mathews advised that South was a permanent employee of the State of Texas and was a non-commissioned officer in charge of maintenance of the armory when he was in Greenville and be assumes that South is carrying on the same duties at Kowth Fort Ened. Eathern stated that be was able to learn that South hai a brother who had been, or still is, with the 849th Division of the Mational Guard at Dallas, Texas.

On December 16, 1964, Dellas T-1 advised that the "South" he referred to previously as the contact of the "Kinutenza" in a possible attent in a maid on a Mortheast Texas Armory was Nolan South. South, whose original home is near Cooper, Texas, presently works for a National Guard Armory in Dallas and is the brother-in-law of Grady R. Turpin of approximately 1728 Aleton Avenue, Fort Worth, Texas. Dallas T-1 advised Turpir is a member of the "Minutexet" group in the Fort Worth area but is not one of the more active nembers. Dallas I-1 advised that some of the members have recently obtained Smith and Wesson Victory Model Thirty-eight opecial revolvers and these revolvers arpear to be new. Dallas T-1 did not know the source of trees revolvers.

On December 17, 1964, a check of current Dallas Telephone Directry reflected that a Rolan F. South resided at 7223 Lake June Road. On December 17, 1964, a check of the current Fort Worth City Directory reflected that Grady R. Turpin, whose wife's name is Eunice E., resides at 1131 Alston Avenue, Fort Worth, and is a machine operator for the Container Corporation. On December 17, 1964, Operator 39, Fort Worth Retail Merchants Credit Association, 508 Commerce Street, Fort Worth, advised that Grady R. Turpin has been in the credit bureau files since December 11, 1943.

Turpin's wives are listed as follows:

In December, 1953, a divorce proceeding was filed by Turpin versus Joan and the divorce was granted.

In December, 1956, a divorce proceeding was noted, Turpin versus Alice.

In February, 1963, it was noted that Turpin was married to Eunice.

Turpin is listed as a repiller in the printing department of the Container Corporation, where he has worked since July 10, 1946. Turpin has lived at 1131 Alston Avenue since at least January, 1953. Turpin's date of birth is listed as October 3, 1925, and no residences other than Fort Worth are shown. Turpin has several repossessions on his credit record.

On December 17, 1964, F. M. Alexander, Identification Division, Fort Worth Police Department, and W. M. Toung, Identification Officer, Tarrant County Sheriff's Office, advised their records contain no information regarding Grady B. Turpin.

On December 21, 1964, Dallas T-1 advised that the local Minutener group has apparently no activities scheduled in this area in the near future, and the group appears quiet at present. Dallas T-1 furnished the following description of Grady E. Turpin whom he described as a member of the local organization:

Turpin's function in the local group is that of a photographer. Turpin is presently employed by the Container Corporation.

Dallas T-1 advised he met Molan South only once about five years ago and could describe him only in that he is a white male American, and his features were characterized by very large protruding ears. Dallas T-1 stated that he has not yet been able to determine South's exact relationship with the organization and does not know whether he is a member.

On January 5, 1965, Penn Jones, Publisher, "Midlothiam Mirror", Midlothian, Texas, advised Delbert Ray resides at Route 3, Midlothian, on a farm known as "White Gate Parm", which Ray is buying on time. Ray is about forty years of age, married and has two daughters. He is employed in Dallas, but his employer is unknown.

In the past, Ray was very active in the John Birch Society which held meetings at Midland in 1961 and 1962. He was then a close associate of Edgar Wesley Seay, another John Bizch-Society member, who was employed by General Edwin Walker. Jones stated that at 2:34 a.m., on April 30, 1962, a lire alara was sounded on an incendiary firs in the office and the "Midlothian Mirror". This fire was caused by a gallon can of gasoline or some other volation, a paper fuse, which had been thrown through the front door.

Although no arrests were made, police felt certain that Seay e liber set the fire or caused it to be set.

On January 14, 1965, Dallas T-1 advised there had been no recent meetings of the "Minutemen" group in the Fort Worth area. An individual known as Ray, the proprietor of a ranch in the Venus-Midlothian, Texas, area, has been responsible for distribution of "On Target", the national "Minutemen" publication to various members of the Fort Worth group.

On January 21, 1965, Dallas T-1, at Fort Worth, Texas, advised that there had been no recent meetings held and none were planned for the immediate future for the "Minutemen" group in Fort Worth. (First Name Unknown) Hudson, believed to be a Sergeant in the National Guard, who either owns or works on a ranch in the area of Bowie, Texas, has recently been seen in the company of several members of the local group. While Hudson is not known to be a member at present of this group, it is possible he may be a target for recruitment.

On January 22, 1965, Chief Warrant Officer Joe R. Rarber, Civilian Personnel Records Office, 49th Armored Division, Texas National Guard, 1779 California Crossing Road, Dallas, Texas, advised that Nolan Franklin South is a Staff Sergeant there and is also a civilian employee as a maintenance man in the motor pool. He said Nolan South has a brother, Luther South, who is also an employee of the Texas National Guard, but Earber did not know where Luther South is presently assigned.

Ee said Kolan South's complete personnel record is maintained at the Civilian Personnel Office, Texas National Guard, Austin, Texas, that a briefer civilian file is maintained by South's direct supervisor, Captain Everett B. Scott at the Armory of the Texas National Guard at the above Dallas address, and that he, Barber, had only South's military file in his office.

Barber said he has known South casually for several years. He said South has been working in the motor pool during his entire exployment there and does not normally have access to firezens or ammunition. Along with other personnel, South fires a familiarization course at the

Army installation at Mineral Wells, Texas, once a year. However, the firearms and ammunition are under the control of one employee at the Armory, who is accountable for such firearms and ammunition, and South would have no way of obtaining unlimited or large amounts of such firearms and/or ammunition.

Earber described South as a man who apparently does not have much education, but makes every effort to give the impression he is well-educated. He said South frequently "talks when he should be listening," i.e., he frequently discusses matters about which he knows little or nothing. However, Earber said, he has never heard South discuss politics or show any interest in racial matters or politics. He and his wife are very active in the Eaptist Church, and South speaks frequently of his activities in that church.

Barber said South has been a civilian employee of the Texas National Guard since May 7, 1956, and is currently earning \$6,427.00 per year.

He made available South's military file which disclosed the following background data:

On May 24, 1964, South completed an "Armed Porces Security Questionnaire" in which he answered in the negative all questions pertaining to membership in or affiliation with the organizations designated by the Attorney General of the Duited States pursuant to Executive Order 10450.

He has won various awards ranging from "Sharpshooter" to "marksman" for his shooting abilities. He has studied automotive mechanics, armor, artillery, and plateon tactics while in the military service.

On January 21, 1965, records of the Edentification
Division and Escords Bureau, Dallas, Texas, Police Department,

On January 22, 1965, records of the Marchants Retail Credit Association, Dallas, were caused to be checked. They disclosed a record for Nolan Franklin South, wife Joyce, who has been in their files since October, 1952, and was last checked Kovember 15, 1963. He lives at 7223 Lake June Road, Dallas. He formerly lived at 1500 South Henderson, Dallas, and at Cooper, Texas, in 1952. In 1952 he was 27 years of age, and had been self-employed in farming for four years. He is employed by the Texas National Guard. He was previously employed by the Ford Motor Company in Dallas.

His credit record is satisfactory except for a debt owed an automobile dealer in 1959, \$1100, which is still owing.

Records of the Dallas Police Department, as caused to be checked on February 8, 1965, contained no information identifiable with Delbert Ray.

Records of the Merchants Retail Credit Association, Dallas, as caused to be checked February 5, 1965, revealed a record for Delbert Ray, last checked in 1960. His residence was Route 3, Eox 182, Midlothian, Texas. His wife was Mary June. Ray was employed by Fred Bell Enterprises. In 1957 he was employed by the Donahue Corporation in Dallas. His address at one time (exact time not shown) was Cedar Hill, Texas, in care of General Delivery. He had been in credit bureau files since 1949. His wife was not employed, and his credit records was satisfactory.

On February 16, 1965, Dallas T-1 advised no recent activities have been noted in the local Fort Worth group of alleged "Kinutenen" and there appears to be no indication at present for current plans for any immediate activity.

Dallas T-1 advised on March 16, 1965, there has been little recent activity of the group in Fort Worth, Texas, aligned similarly to the "Minutemen" organization. The group's plane to burglarize a local National Guard Armory have not materialized, as recently the group has noticed further security precautions, including night lighting, are being taken at armories.

"Ray", who appears to be the highest group official in the area, is speaking more of retired General Edwin Walker's guidance and leadership of the organization. He speaks in near reverent terms concerning Walker. Dallas T-1 advised that "Ray" was arranging a meeting with General Walker for him, but after further consideration, decided it would not be appropriate at this time, because Walker becomes suspicious of those who too quickly attempt to meet him. "Ray" advised that it would be wiser to wait until the General requests to see him or until he had been in the organization a longer period of time.

Dallas T-1 further stated that William Seals of Houston, Texas, formerly of Fort Worth, has not been recently in contact with the group in Fort Worth.

Dallas T-1 advised he had no information that the group had yet established a local storehouse or arsenal for weapons and that the membership and leaders in the local group have remained unchanged.

NATION OF ISLAM, formerly referred to as the Muslim Cult of Islam, also known as Muhammad's Temples of Islam

In January, 1957, a source advised Elijah Muhammad has described his organization on a nationwide basis as the "Nation of Islam," (NCI) and "Muhammad's Temples of Islam."

On May 8, 1964, a second source advised Elijah Muhammad is the national leader of the NOI; Muhammad's Temple of Islam No. 2, 5335 South Greenwood Avenue, Chicago, Illinois, is the national headquarters of the NOI; and in mid-1960, Muhammad and other NOI officials, when referring to Muhammad's organization on a nationwide basis, commenced using either "Mosque" or "Temple" when mentioning one of "Muhammad's Temples of Islam."

The NOI is an all-Negro organization which was originally organized in 1930 in Detroit, Michigan. Muhammad claims to have been selected by Allah, the Supreme Being, to lead the so-called Negro race out of slavery in the wilderness of North America by establishing an independent black nation in the United States. Members following Muhammad's teachings and his interpretation of the "Koran" believe there is no such thing as a Negro; that the so-called Negroes are slaves of the white race, referred to as "white devils," in the United States and that the white race, because of its explcitation of the so-called Negroes, must and will be destroyed in the approaching "War of Armageddon."

In the past, officials and members of the NOI, including Muhammad, have refused to register under the provision of the Selective Service Acts and have declared that members owe no allegiance to the United States.

On May 5, 1958, the first source advised Muhammad had, upon advice of legal counsel, tempered his personal statements and instructions to his ministers concerning the principles of his organization in order to avoid possible prosecution by the United States Government; however, he did not indicate any fundamental changes in the teachings of his organization.

On May 7, 1964, a third source advised Muhammad had, early in July, 1958, decided to de-emphasize the religious aspects of the teachings of Islam and to stress the economic benefits to be derived by those Negroes who joined the NOI. This policy change, according to Muhammad, would belp him acquire additional followers and create more interest in his programs.

In his book "This Time The World," copyrighted in 1961, George Lincoln Rockwell identified himself as Commander, American Nazi Party of the World Union of Free Enterprise National Socialists (ANP - WUFENS), Arlington, Virginia.

The April 4, 1963, issue of "The Richmond News Leader," a Richmond, Virginia, daily newspaper, reported that George Lincoln Rockwell had, on the previous day, again applied for the American Nazi Party to be chartered in the State of Virginia, but this request was turned down by the Virginia State Corporation Commission. This action was taken pursuant to an act of the 1962 Virginia Assembly which prohibits use of "Nazi" or "National Socialism" in a Virginia charter. This article further pointed out that Rockwell's party is presently chartered in the State of Virginia as the George Lincoln Rockwell Party.

On August 14, 1964, a source advised that the ANP - WUFENS was organized by George Lincoln Rockwell at his residence in Arlington, Virginia, on February 26, 1959, as an international "National Socialist" movement based on the German Nazi Party headed by Adolf Hitler. He added that Rockwell is the dominant force and personality in this party; that he is espousing a "line" of hatred against the Jews and Negroes; and that he is seeking, through speeches, distribution of literature and picketing, to establish a cohesive and dominant political party in the United States and in foreign countries.

According to the "Stormtrooper's Manual," an official publication of the AMP, the phases of AMP struggle for power are fourfold, namely, first "to make ourselves known to the masses;" second "the dissemination of our program and the truth about the Party;" third "organizing

On February 17, 1964, Karl Rogers Allen, Jr., former Deputy National Commander of the ANP, advised that George Lincoln Rockwell believes that he has completed the first two phases in his struggle for power and is now well into the third phase. Allen said, however, in his opinion, Rockwell has only completed phase one.
