In connection with its investigation into the circumstances surrounding the death of President Kennedy, the Select Committee on Assassinations requests access to the following information:

- l. Any and all reports and documents, including indices and records under any pseudonyms, concerning or referring to Jose Luis Romero. Romero is believed to be a pseudonym. Romero reportedly served in the French military in Algeria in the 1950's and worked with American intelligence. He was reportedly also an agent of the French secret military organization O.A.S.
- 2. Any and all reports or documents concerning or referring to any French nationals or citizens involved in plots or conspiracies to assassinate President Kennedy or Fidel Castro.
- Y 3. Any and all reports or documents concerning or refering to PIERRE OWEN DIEZ DE URE. Ure is reportedly a French national who lived in Cuba in the early 1960's and assisted American intelligence.
- V4. Any and all documents concerning or referring to VALENTIN VASILEVICH BAKULIN. Served at Soviet Embassy in Mexico City in 1959. Referred to in FBI files on Norman Rothman.

- 5. Any and all documents concerning or referring to OPERATION PROUDFOOT, including all indices.
- 6. Any and all documents concerning or referring to OPERATION PATHFINDER, including all indices.
- 7. Any and all documents concerning or referring to JAGGERS-CHILES-STOVALL CORP. in Dallas, Texas.
- /8. Any and all documents concerning or referring to RICARDO MORALES-NAVARETTE, aka Ricardo Navarette-Morales.
