4th para Circumstances already
developed here point to possibility that
Oswald may have been Castro's agent.
Mexicans are also keenly aware of this
possibility.

5th para using CIA channels for
reporting - not using State Dept.
Channels.

to Mexican authorities

6th para - two intercepts of the
Dosticos-Hernandez Armas phone conversation
- concern whether Mexicans questioned
Duran about money.

7th para - Alvarado - double
agent (Cuba and Nicaragua) story
is without fault except a consultant

employee who admits talking to him
can't be found.

D. Oswald went to Cuban consulate
for address of the hotel he stayed in.

Nicaraguan official talks to Alvarado who goes back to original story. Says Mexicans threatened him w/ physical violence. Previous flaw in story is date of Sept 18 and that she tried to call the embassy 4 times Sept 20 under name of Jorge Rynaud and was refused by a woman.

Wheelock agrees to interrogation of Alvarado in Nicaragua.
