1 Mr. Schwarz. Now, Mr. Bissell, we went over the notes
2 in the other room, didn't we?

3 Mr. Bissell. Correct.

4 Mr. Schwarz. And I told you that Mr. Harvey testified that
5 those dates, 25-1 and 26-1 were January 25 and January 26?

6 Mr. Bissell. Correct.

7 Mr. Schwarz. And in reading the handwritten document
8 together, we agreed that it was talking about Executive Action,
9 didn't we?

10 Mr. Bissell. I think that is correct. Yes, I think that
11 is fair.

12 Mr. Schwarz. And it reflected a meeting between Mr.
13 Harvey and then in the first instance Mr. ~~Gottlieb~~ and in the
14 second instance Mr. Arnold Silver, is that correct?

15 Mr. Bissell. Correct.

16 Mr. Schwarz. All right.

17 Now, in light of that document, those dates, excuse me,
18 does that have any effect upon your prior testimony that you had
19 no reason to question Mr. Harvey's statement that at the occa-
20 sion you asked him to set up the capability you said that the
21 White House had twice urged you to do so?

22 Mr. Bissell. Yes. I think these dates do call that into
23 question, because, accepting these dates, which are Mr. Harvey's
24 own notations, it is clear that I had given him at least some
25 exposure to that assignment at the end of January, just at the
