On 10/28/64, ARMANDO GATELL, Delegate General of the SNFE, Fort Worth, Texas, and MANUEL RODRIGUEZ, President of the SNFE, Dallas, and GUILLERMO RUIZ, a resident of Fort Worth and a member of the Fort Worth SNFE, all of whom are Cuban refugees, were interviewed at the home of RODRIGUEZ, 2311 Nicholson Drive, Apartment D, Dallas, by SA WALLACE R. HEITMAN. RODRIGUEZ had previously made arrangements for this meeting as he explained that he, and GATELL had information concerning the Fort Worth Chapter of the SNFE which they desired to furnish.
