THE INFORMANT WAS OSCAR ANGULO REYES, A REPORTER FOR CUBAN NEWSPAPERS, WHO WAS BY COINCIDENCE IN THE COURTROOM AT THE TIME OF THE MOTION. HE HAD ADVISED THAT HE HAD RECEIVED INFORMATION FROM BOSCH'S WIFE THAT BOSCH HAD TOLD HER THAT IF HE WERE RELEASED HE WOULD IMMEDIATELY ARRANGE FOR THE BOMBING OF ANOTHER SHIP. ~~(S)~~(u)

WHEN THE GOVERNMENT REFUSED TO IDENTIFY THE INFORMANT THE DEFENSE REQUESTED TO KNOW THE NATURE OF THE INFORMATION FURNISHED. THE GOVERNMENT REFUSED TO STATE SPECIFICALLY IN OPEN COURT, FOR TO DO SO WOULD IMMEDIATELY SERVE TO IDENTIFY THE INFORMANT BECAUSE OF THE NATURE OF THE INFORMATION, PARTICULARLY SINCE IT HAD IN FACT ORIGINATED WITH BOSCH'S WIFE, WHO PRESUMABLY HAD NOT TOLD MANY PEOPLE OF BOSCH'S PLAN. ~~(S)~~(u)

JUDGE MEHRTENS THEN SAID THAT HE WOULD ACCEPT TESTIMONY IN HIS CHAMBERS CONCERNING THE IDENTITY OF THE INFORMANT AND THE NATURE OF THE INFORMATION FURNISHED. DEFENSE COUNSEL GREENSPAHN REQUESTED TO BE PRESENT AT THE HEARING IN THE CHAMBERS BUT THE GOVERNMENT REFUSED BECAUSE HE WOULD THEN KNOW THE IDENTITY OF THE INFORMANT AND THE INFORMANT'S LIFE WOULD THEN BE PLACED IN JEOPARDY. JUDGE MEHRTENS CHECKED PRECEDENT
