JACK LESLIE BOWEN, Federal Correctional Institution (FCI), La Tuna, Texas, Number 46512-146, was interviewed at this institution at which time he was advised of the official status of Special Agent HAROLD H. BOYCE of the Federal Bureau of Investigation (FBI).

At the outset, JACK LESLIE BOWEN was advised of his rights and furnished with a document or form advising him of his rights and he pointed out that he fully understood his rights and this document but would not sign a Waiver of Rights or make a statement.

JACK LESLIE POWEN advised that his true name is JOHN CAESAR GROSSI, however, he was arrested and booked and convicted of the Dyer Act and sentenced to three years in United States District Court at Albuquerque, New Mexico, under "A2" sentence under the name of JACK LESLIE BOWEN.

BOWEN or GROSSI was advised that the Assistant United States Attorney (AUSA) in the Federal District of Arizona had declined prosecution concerning him relative to a 1970 Oldsmobile station wagon taken in Columbus, Georgia, and left in Phoenix, Arizona, in view of the three year sentence he had received at Albuquerque, New Mexico.

He was also advised the purpose of this interview was concerning the 1969 Kercury rented in Macon, Georgia, and concerning a 1969 Cavenan autohome reported stolen in Grants Pass, Oregon.

JOHN CAESAR GROSSI or JACK LESLIE BOWEN stated that he was not inclined at this time to say anything further concerning the 1969 Mercury or of a Caveman auto home or of anything else. He pointed out that the same situation exists at this time as it did when he was at the Montessa Detention Center in Albuquerque. New Mexico, in the middle part of May, 1970, when he received a telephone call from some man who represented himself as being an insurance agent and inquiring if he had ever borrowed a Caveman auto home in Oregon and if he knew its present whereabouts. He pointed out that he told this man making the telephone inquiry the same thing that applies now that anything concerning these matters would have to be taken up with his Attorney LAWRENCE BUCHNILLER of Albuquerque, New Mexico, who had been appointed to represent him in his conviction and case handled there.

JACK LESLIE BOWEN, who states his true name is JOHN CAESAR GROSSI, pointed out that from November of 1968 to February, 1969, he operated as an informant for the FBI at Baltimore, Maryland, and Buffalo, New York. He pointed out that he was able to secure information on criminal activities of highly placed hoodlums. He pointed out that he had brought this to the attention of the FBI upon his recent arrest and conviction of Dyer Act charges in an effort to obtain some type of leniency on his behalf and it was apparent that nothing could be done or was done to alter his prosecution. GROSSI noted that under the "A2" sentence that he can come before the Parole Board for a hearing scheduled sometime in August of 1970.
