ON APRIL ONE, INSTANT, CARLOS ZARRAGA MARTINEZ, KEY SOURCE - CUBA, ADVISED THAT ABOUT ONE WEEK AGO, RICARDO ~~MORALES~~ NAVARRETE SAID HE WAS RESPONSIBLE FOR THE BOMBING OF THE SPECIALIZED SERVICES, JAN. TWENTYFIVE, LAST, FOR WHICH HE WAS ARRESTED. (X) (U)

MORALES TOLD SOURCE HE HAD PREVIOUSLY CONTACTED ENRIQUE HUERTAS, PRESIDENT OF THE CUBAN MEDICAL ASSOCIATION IN EXILE, AND PROPOSED CERTAIN ANTI-CASTRO ACTIVITIES AND REQUESTED MONEY FOR THESE ACTIVITIES. HUERTAS DID NOT SAY NO, BUT ACTED IN AN UNUSUAL WAY BY GIVING MORALES A CODE NAME AND
