Enclosed herewith are five copies of a letterhead memorandum concerning captioned matter.

Source is BRUNILDA CUMPIANO, who was formerly a Social Reporter at "El Imparcial" newspaper and, after joining the Teamsters Union, began to associate with Teamsters officials. Her knowledge of Teamsters activities is a result of her association with these officials.

Source attended George Washington University, Washington, D. C., spent two years in the Army, and for a time was employed by G-2. She was interviewed by Agents of the SJO as a result of a telephone call from her doctor, who stated that source had expressed to him deep concern over the activities she had observed in connection with her association with FRANK CHAVEZ and members of the Union. At the time of interview source was in the Mimiya Clinic undergoing a treatment for hyperthyroid.

No action is being taken by the SJO at the present time regarding information contained in the enclosed letterhead memorandum; however, Bureau authority is requested to contact CUMPIANO again for additional information concerning Teamsters Union activities in SJ.

No local dissemination is being made of instant material.
