Mrs. CATHERINE TAAFFE advised on 1/9/59, that she spoke to DON HOGAN, Public Relations Director of July 26th, who advised her this date that he was leaving for Havana on Cubana flight leaving Idlewild at 3:30 p.m., this date.

DON HOGAN also advised TAAFFE that he had completed the papers for registration as a foreign agent of the new Cuban Government and was submitting them to the Justice Department, this date.

Mrs. TAAFFE also stated that she ascertained from HOGAN that ALBERTO FERNANDEZ CASAS had been appointed yesterday as head of the Sugar Institute in Cuba.
