FIRM IN SAN JUAN HAD TENTATIVELY OFFERED FUNDS FOR BOSCH
CAUSE. (u)

ANGULO STATED BOSCH GROUP IS COMPLETELY DISORGANIZED
AS RESULT OF RECENT TRIAL AND CONVICTION OF BOSCH AND
ASSOCIATES AND GARCIA APPEARS TO BE ONLY REMAINING ACTIVE
MEMBER. GARCIA IS SEVENTYFOUR YEAR OLD CUBAN WHO IS LONG
TIME ASSOCIATE OF ORLANDO BOSCH. (u)

UPON RECONTACT, ON JANUARY TWO INSTANT, ANGULO STATED
HE HAD NOT SEEN GARCIA SINCE DECEMBER TWENTYEIGHT LAST AND
DID NOT KNOW IF HE TRAVELED TO PUERTO RICO AS SCHEDULED OR
MAY HAVE BEEN THERE ON DECEMBER THIRTY LAST. ANGULO
WILL VISIT HOME OF GARCIA IN EFFORT TO DETERMINE ADDITIONAL
INFORMATION AND BUREAU AND SAN JUAN WILL BE ADVISED. (u)
