A copy is also being furnished to the U. S. Attorney, Miami, attention of THEODORE KLEIN, AUSA.

The Miami Office has not interviewed JORGE GUTIERREZ, one of the two sources of YANKS' report, because it appears obvious that GUTIERREZ is attempting to ingratiate himself with the Federal Government in hopes of receiving some form of leniency in this case. [ Miami has received information from MM 1337-S which reflects that JORGE GUTIERREZ is no longer on friendly terms with the defendants mentioned in this case. MM 1337-S, who is closely associated with several members of the BOSCH group, reported on 9-16-69, that he had received no evidence whatsoever that any of the defendants plan to depart the United States. ] (u)

The Miami Office realizes, of course, that there is a possibility that one or more of these defendants might possibly attempt to skip their bond and appropriate sources have been alerted.
