of the extreme caution being exercised in connection with the Army's source in this matter at Ft. Jackson, South Carolina.

It is requested that the Savannah Office, at Ft. Jackson, South Carolina, at its earliest convenience, attempt to interview Army's source in this matter, with a view toward pinning this informant down as to specifics in this matter.

For the information of Savannah, attempts to identify the registrant of 1963 Florida License 1D-49526 have been negative to date, as registration papers are not yet on file at the Dade County Automobile Tag Agency. Such information will be furnished to Savannah when it is available at Miami.

As the Bureau and Savannah are aware, details concerning this case, based on information furnished by Savannah, was discussed with Assistant Attorney General J. WALTER YEAGLEY on the morning of March 30, 1963, at Miami, by SA LEMAN L. STAFFORD, JR. Mr. YEAGLEY authorized institution of an investigation to determine if there have been any violations of the Neutrality Statutes.

Miami is maintaining contact with local Federal agencies and informants in a position to furnish information concerning activities of this organization.
