1. A representative of this Agency reported on 17 January 1967, that Raul W. PELEGRINA called our representative to report that the Nino Diaz group which he had previously reported on, now had obtained a farm near FAJARDO near Los Coabas to be used by them as a training site. The group planned to train about fifty men at this farm and had asked PELEGRINA to do the training. Some of the trainees were to be brought to Puerto Rico from the United States. The group also now had three boats that were capable of carrying 15-20 people each. The group had \$50,000 worth of arms and ammunition, mostly United States M-1's and other WWII surplus weapons. So far the group had asked him to repair a P-38 Walthers. They are trying to rush the training and are anxious to get started with the invasion.

2. PELEGRINA also reported that the Consuls of Haiti, Costa Rica, and Paraguay, in Puerto Rico, have been attending the meetings of this group and apparently are supporting the intentions of the group and possibly lending material support.

3. According to PELEGRINA, one Roberto ROCA is the leader of the Puerto Rican section of the Nino Diaz group. They have a 110 foot boat that is being made seaworthy in the Miami, Florida, area. They have asked for a 25 mile radar from the United States Government.

4. Our representative reiterated to PELEGRINA that he should report his information to Mr. John HAMMETT of the Federal Bureau of Investigation in Puerto Rico and to follow whatever instructions HAMMETT gave him. He told our representative that he has been meeting with HAMMETT about once a week and just wanted to be sure that our representative was kept informed.
