DEPARTING FOR MOBILE. THE BOMB CONTAINED AS WADDING, A NEW ORLEANS NEWSPAPER DATED AUGUST TWENTYTHREE, SIXTYEIGHT.

PRELIMINARY INDICATIONS ARE THAT THE BOMB WAS PLACED MOST LIKELY AT NEW ORLEANS, BUT COULD HAVE BEEN PLACED MOBILE.

A CONFIDENTIAL MIAMI SOURCE, WHO FURNISHED THE INFORMATION CONCERNING THE BOMB ON THE LANCASTRIAN PRINCE, REPORTED ON EVENING SEPTEMBER TWELVE THAT HE HAD JUST BEEN INFORMED BY ANDRES JORGE GONZALEZ, BOSCH'S CHIEF BOMB EXPERT, THAT HE HAD BEEN INTERVIEWED BY FBI TWO DAYS PREVIOUSLY CONCERNING GONZALEZ'S WHEREABOUTS DURING THE PAST TWO WEEKS. GONZALEZ RELATED THAT HE TOLD FBI HE HAD BEEN IN MIAMI DURING THAT TIME, BUT GONZALEZ SAID HE HAD ACTUALLY BEEN AT THE SAME PLACE WHERE HE HAD PLACED THE BOMB ON THE LANCASTRIAN PRINCE. GONZALEZ THEN DISCLOSED THAT HE HAD PUT A BOMB ON A SMALL SPANISH SHIP AT THIS PLACE, AND THAT THIS BOMB SHOULD EXPLODE WITHIN THE NEXT FIVE OR SIX DAYS. HE SAID HE TOOK PHOTOGRAPHS OF THIS SPANISH SHIP FOR THE NEXT PRESS RELEASE OF CUBAN POWER ABOUT THIS BOMBING. HE CLAIMED HE IS USING NEW EQUIPMENT WHICH ENABLES HIM TO REMAIN UNDER WATER FOR FIVE CONSECUTIVE HOURS, AND THAT HE HAS A NEW TYPE OF FLOAT FOR TOWING THE BOMB UNDERWATER. GONZALEZ ALSO STATED THAT HE HAS THREE MORE BOMBS READY TO PUT ON SHIPS. GONZALEA DID NOT DISCLOSE THE NAME OF THE SMALL SPANISH SHIP NOR STATE THE NAME OF THE PORT WHERE THE BOMB HAD BEEN PLACED, EXCEPT BY DISCLOSING IT AS THE PLACE WHERE BOMB HAD BEEN PUT ON THE LANCASTRIAN PRINCE. (u)

GONZALEZ WAS IN FACT INTERVIEWED BY AN FBI AGENT BEGINNING AT APPROXIMATELY NINE THIRTY AM, SEPTEMBER TEN, AT WHICH TIME GONZALEZ DENIED HE HAD BEEN OUT OF TOWN DURING THE PAST TWO WEEKS.

THE MIAMI SOURCE IS OSCAR ANGULO REYES PSI UNDER DEVELOPMENT. IF BOMB FOUND, PUBLIC DISCLOSURE AT THIS POINT WOULD JEOPARDIZE LIFE AND SAFETY OF ANGULO - PROTECT. (X)(u)

SA ROBERT STRONG INTERVIEWED GONZALEZ ON SEPTEMBER TEN. X PRIOR CONTACT WITH GONZALEZ'S SISTER BY MIAMI SOURCE, ANGULO, ON NINE ONE SIXTYEIGHT, INDICATED GONZALEZ WAS "OUT OF TOWN ON A MISSION" AND SPOT CHECKS OF GONZALEZ'S RESIDENCE FAILED TO REVEAL HE RETURNED TO MIAMI PRIOR TO DATE OF HIS INTERVIEW. (X)(u)

NEW ORLEANS AND MOBILE ARE REQUESTED TO IMMEDIATELY ALERT U.S.C.G. AND APPROPRIATE HARBOR AND DOCK OFFICIALS, AND IDENTIFY ALL SPANISH SHIPS WHICH WERE AT PORTS OF NEW ORLEANS AND MOBILE DURING PERIODS EXTENDING FROM SEPTEMBER TEN BACK TO AUGUST TWENTYTHREE. APPROPRIATE ARRANGEMENTS IF POSSIBLE, SHOULD BE MADE TO HAVE ANY SPANISH SHIPS STILL IN PORT FALLING WITHIN THIS CATEGORY SEARCHED FOR BOMBS, AND SHIP AGENTS OR OWNERS NOTIFIED VIA U.S.C.G. WHERE ANY SUCH SHIPS HAVE DEPARTED FROM PORT. MIAMI HAS PREVIOUSLY PROVIDED NEW ORLEANS AND MOBILE WITH PHOTOGRAPHS AND DESCRIPTIONS OF CUBAN POWER ACTION GROUP.

CAPT. TOM BRODIE, BOMB EXPERT, DADE COUNTY SHERIFF'S OFFICE, MIAMI, WHO DISMANTLED THE BOMB FOUND ON THE LANCASTRIAN PRINCE, HAS PREVIOUSLY EXPRESSED A WILLINGNESS TO PERFORM SIMILAR SERVICES ANYWHERE REQUESTED, ON EXPENSE BASIS ONLY.

IF ANY BOMB FOUND AND DISMANTLED, BOMB AND ITS COMPONENTS SHOULD BE FURNISHED FBI LAB FOR APPROPRIATE EXAMINATION.

NEW ORLEANS AND MOBILE ADVISED TELEPHONICALLY, AND AMSD COPIES SENT TO THESE OFFICES. U.S. COAST GUARD, STATE DEPARTMENT MIAMI BEING ADVISED "
