Re report of SA JAMES O. INGRAM, at New York dated 4/20/64.

A review of the indices of the NYO contain no additional information concerning the subject since the submission of referenced report.

On 3/15/65, MALCOLM MORRISON, Superintendent, at 310 West 94th Street, NYC, advised SA WILLIAM L. QUIS that the subject's in-laws, Dr. MORTON and ROSE SCHWEITZER, continue to reside in apartment 2-E at the above address. MORRISON stated that he had learned from general conversation among the tenants in the building that the SCHWEITZERS have indicated the subject and his wife are still residing abroad. MORRISON stated he, himself, has not seen the subject or his wife in the building, and had no information to the effect that the subject had returned from Cuba.

The following informants, all who have knowledge of certain Cuban activity in the New York City area, were contacted on the dates listed below and all advised they had no information concerning the subject's return to the United States or any activity on his part in the New York area:
