Enclosed for the Bureau are five copies of a letterhead memorandum containing information concerning the subject.

The confidential source utilized in this memorandum is Mr. JAMES H. RAND, President of the Rand Development Corp. in Cleveland, a confidential source of the Cleveland Office who has furnished reliable information in the past and whose identity is concealed at his request.

The letterhead memorandum is classified confidential since the information contained therein could reasonably result in the disclosure of the identity of Mr. RAND, a source of continuing value to the Cleveland Division and jeopardize his future effectiveness.

No further investigation appears warranted at Cleveland at this time and this case is being placed in a closed status.
