The confidential source utilized in this memorandum was Mr. H. JAMES RAND, President of the Rand Development Corporation of Cleveland, a confidential source of the Cleveland Office who has furnished reliable information in the past and whose identity is concealed at his request.

The information in the enclosed letterhead memorandum was furnished to SA MILTON P. MANDT.

This letterhead memorandum is classified confidential since the information contained therein could reasonably result in the disclosure of the identity of [Mr. RAND], a source of continuing value to the Cleveland Office, and jeopardize his future effectiveness.

No further investigation is warranted at Cleveland at this time, and this case is being placed in a closed status.
