The source used in this letterhead memorandum is Mr. H. JAMES RAND, President of the Rand Development Corp. of CV, a confidential source of the CV office, whose identity is concealed at his request. (S)(u)

Mr. H. JAMES RAND advised SA MILTON P. MANDT on 5/14/62, that he could see no reason for the subject coming to CV when he returns from Russia except to exchange greetings with people he formerly knew at the Rand Development Corp. CV will continue to maintain contact with the Rand Development Corp. regarding the subject. (S)(u)

This letterhead memorandum is classified confidential since the information contained therein could reasonably result in the disclosure of the identity of Mr. RAND and consequently jeopardize his future effectiveness. (S)(u)
