Re New York letter to the Bureau dated 10/21/66.
Re Baltimore letter to the Bureau dated 11/7/66.

BA 1121-PSI and BA 1328-PSI (whose informant reports are being forwarded to New York) advise in substance that subject spoke at 242 South Broadway, Baltimore, Maryland, on 11/11/66. She was introduced by TOM BOWERS, Communist Organizing Committee member, as SUE WARREN, member of the Progressive Labor Party. Subject spoke on the cultural revolution in China and was pro Red Chinese in her presentation.

A review of Bafile 100-22530 on subject's husband, RICHARD CYRIL FRANK, indicates subject and husband are identical with the DICK and SUSAN BA 975-S met in Moscow in 5/61.

New York is reminded that subject's photograph was requested by Baltimore in above referenced Baltimore letter. Baltimore intends to display this photograph to informants in Maryland who have contact with subversive groups likely to be in touch with subject.

Baltimore will advise New York of results of display of photograph.
